## **HOW TO ENTER:**

A participant will be entered in the giveaway once they have successfully completed submission of the entry form, and provided that they meet all eligibility requirements as outlined in these Official Rules.

Sweepstakes registration starts on **1/3/2022** between 8:00 AM – 5:00 PM EST and continues until **2/7/2022 at 11:59 PM EST**. Winners will be selected by random electronic drawing during the week of **2/7/2022** and be notified via e-mail.

## CONSUMER DISCLOSURE:

Each winner will be notified by email. Winner will be required to reply to the notification e-mail, acknowledging their designation as a winner and providing a mailing address. It is preferable that the winner respond within 1 business day acknowledging their prize and confirming their mailing address, since they will be announced as the winner the next business day, regardless of whether their mailing address has been received. If the Sweepstakes Administrator does not receive this response from the winner within 5 business days of notification, the prize will be forfeited.

## ELIGIBILITY:

To be eligible, you must be a legal resident of the 50 United States, or District of Columbia, and over 18 years of age at the time of entry. You must be a Social Studies or an American History teacher at a school in Tennessee or homeschool teacher in Tennessee.
